
**OLD BUSINESS:**

**NEW BUSINESS:**



- T-SPLOST – Roads List – these will be carried with us to county meeting on the 20<sup>th</sup>. Andrews Dr, Wright Ave, Manor St, Rucker St and the drainage/mulching from Hwy 80 thru to behind the Storage Units.

With no further business a motion was made by Robert Cody to adjourn, a second was made by Josh Patterson at 7:07 pm. The vote was unanimous.








